1 I, Chaile Steinberg, declare as follows:

2 1. I respectfully submit this declaration in support of final approval of the settlement of the  
3 above-captioned action for \$7,500,000.00 (the "Settlement"). I also submit this declaration in support  
4 of my request for reimbursement of \$1,000.00 for time spent and expenses incurred in carrying out my  
5 responsibilities to the Class.<sup>1</sup> I have personal knowledge of the statements herein, and if called as a  
6 witness, could competently testify thereto.

8 2. After consultation with legal counsel, I made the decision to become involved in this  
9 action as a named Plaintiff and understood my responsibility to serve the best interests of the Class.

10 3. To that end, I consulted with counsel regarding the litigation and I was informed  
11 regarding the terms of the settlement. I approved the settlement as put forth in the Motion before the  
12 Court. In making the determination that the settlement represented a fair, reasonable and adequate  
13 result for the Class, I weighed the substantial benefits to the Class against the significant risks and  
14 uncertainties of continued litigation. After doing so, I believe that the Settlement represents a highly  
15 favorable recovery, and believe that final approval of the Settlement is in the best interest of the Class.

17 4. I understand the Court may make an award of reasonable costs and expenses directly  
18 relating to the representation of the Class to any representative serving on behalf of the Class. I am  
19 requesting the amount of \$1,000.00 in connection with my representation of the Class. This request is  
20 based on my hours of participation in the case and responsibility for protecting the best interests of the  
21 class.
